

Voter Registration List. Tennessee Code Annotated 2-2-138 allows the purchase of a list of registered voters for Montgomery County from the Election Commission Office. The voter list is to be used for political purposes only. False certification is a Class B Misdemeanor, punishable by a fine of \$500.00. We are able to provide this list on a computer printout or CD-R. The voter information provided is voter *data* only. It does not contain any software to print lists. You must have computer software of your own to use the information and you must understand how to import the voter data into your program. The voter registration records are updated daily. You should place your order prior to the time you will need it since we cannot guarantee a turnaround time for your order due to the changing workload. We will call you as soon as it is ready to be picked up.
